Meet the Camp Directors

Jeff Bowers

Jeff Bowers, the head women's soccer coach at Virginia Wesleyan University has compiled an overall record of 249-79-35 with the Marlins and has received numerous accolades, including 2005 Old Dominion Athletic Conference Coach of the Year honors as well as South Region Coach of the Year honors in 2003 and 2005.

He guided the Marlins to their most successful season ever in 2006, highlighted by an Old Dominion Conference Championship and a Final Four NCAA finish. He also coached the semi-professional Hampton Road Piranhas, in 2004 and 2005. Bowers holds a Premier License from the United Soccer Federation and a "B" license from the United States Soccer Federation.



Chris Mills

A Virginia Beach native, he has been a part of the VWU program as a player and coach since 2002. He was a part of the 2007 Sweet Sixteen team that was the most successful in program history. As head coach, he led the Marlins to their best record since 2007, the ODAC Conference Championship, and an NCAA tournament berth in 2013. In his tenure as head coach, Mills has produced ODAC and Virginia rookies of the year, All-region and All-Virginia honorees, and has been named ODAC Coach of the Year.

A 2006 Virginia Wesleyan graduate with a major in Recreation and Leisure Studies, Mills was a standout defensive player for the Marlins. He was a three-time All-ODAC Conference honoree and two-time All-Virginia honoree, helping lead the team to an overall record of 57-17-5, a 27-7-2 ODAC mark, and two NCAA appearances. Mills holds an Advanced National Coaching License from the United Soccer Federation.

Campers will not be refunded for any modification to camp.

HEALTH, SAFETY, AND COVID-19 PROTOCOLS

Marlin Soccer Academy is committed to providing a safe and healthy environment for all its campers, parents, Coaches, and guests. We recognize that through the implementation of the following coordinated efforts, we can greatly reduce, not eliminate, the risk of COVID-19 transmission in our campus community. We strive to balance our mitigation strategies with the known benefits of children experiencing in-person summer camps.. Parents will be notified if updates are made.

PRE-CHECK

If your child(ren) has tested positive for COVID-19 in the last 10 days, has a known exposure to a person with or suspected to have COVID-19 in last 14 days your child(ren) should not come to camp. If your child(ren) had any of the following symptoms in the last 24 hours your child(ren) should not come to camp: cough, shortness of breath or difficulty breathing, fever \geq 100.4° Fahrenheit or chills, muscle or body aches, sore throat, fatigue, congestion or runny nose, new loss of taste or smell, headache, nausea or vomiting, diarrhea.
